**INVITATION FOR BIDS**

**Construction of Commune Dissemination and Training Centers**

1. The Royal Government of Cambodia (RGC) represented by the Ministry of Economy and Finance has received a grant from Global Agriculture and Food Security Program (GAFSP) through the Asian Development Bank toward the cost of Emergency Food Assistance Project-Additional Financing and it intends to apply part of the proceeds of this grant to payments under the Contract **No. EFAP (AF)-NCB-PGO-15-05** for Construction of Commune Dissemination and Training Centers consisting of the following Lots:

Bids may be submitted for one Lot or combination of Lots while separate contracts may be awarded for single Lot or combination of Lots to bidders who submit bid(s) that resulted in the lowest evaluated bid price(s) and subject to meet the qualification criteria set forth under Sub-Clause ITB 6.3.

2. The CPMU now invites sealed bids from eligible and qualified bidders for Tender No. **EFAP (AF)-NCB-PGO-15-05**, Construction of Commune Dissemination and Training Centers. The construction period is Ninety (**90**) days. The CPMU would like to complete the construction on time and would not like to extend the construction period further.
3. Bidding will be conducted through "the National Competitive Bidding (NCB) procedures specified in the RGC's procurement manual and in accordance with the Financing Agreement and the Guideline for Procurement under Asian Development Bank Loans".
4. This invitation is open to all eligible bidders from eligible member countries as described in the bidding document.
5. Interested eligible bidders may obtain further information from the address below and inspect the bidding documents at the address below from Monday to Friday during office hours from **8:30 to 12:00** and from **14:00 to 17:00** hours.
6. Interested bidders' attention is drawn to Sub Clause 6.3 of the Instructions to Bidders and the Qualifications requirements mentioned there.
7. A complete set of bidding documents in English may be purchased by interested bidders on submission of a written application to the address in paragraph 10 and upon payment of a non-refundable fee of **USD 20.00** or its equivalent in Cambodian Riel being **80,000.00 Riels**. The method of payment will be in cash. The bidding document will be collected in person at the discretion of bidder. Other than payment of the non-refundable fee specified above, there shall be no other conditions for the purchase of the bidding documents.
8. In case of any difficulty in purchase of bidding documents, prospective bidders may contact in writing to H.E. 9. Bids must be delivered to the address given below on or before **10:00** hours (local time) on **8 July 2015**. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person on **10:00** hours (local time), **8 July 2015**.
10. All bids shall be accompanied by a Bid Securing Declaration as described in the Instructions to Bidders.
11. The Government of Cambodia and the Funding Agency will respectively declare a firm ineligible either indefinitely or for a stated period of time, to be awarded a contract funded by the Government of Cambodia and the Funding Agency, if it at any time determines that the firm has engaged in corrupt or fraudulent, coercive or collusive practices in competing for or in executing a contract.
